## [5] Transportation (TR)

### Pedestrian Path Policy on Campus

#### 1. Purpose

This policy aims to ensure the safety and comfort of pedestrians on campus, including students, faculty, staff, visitors, and other authorized persons.

#### 2. Scope

#### 5. Enforcement

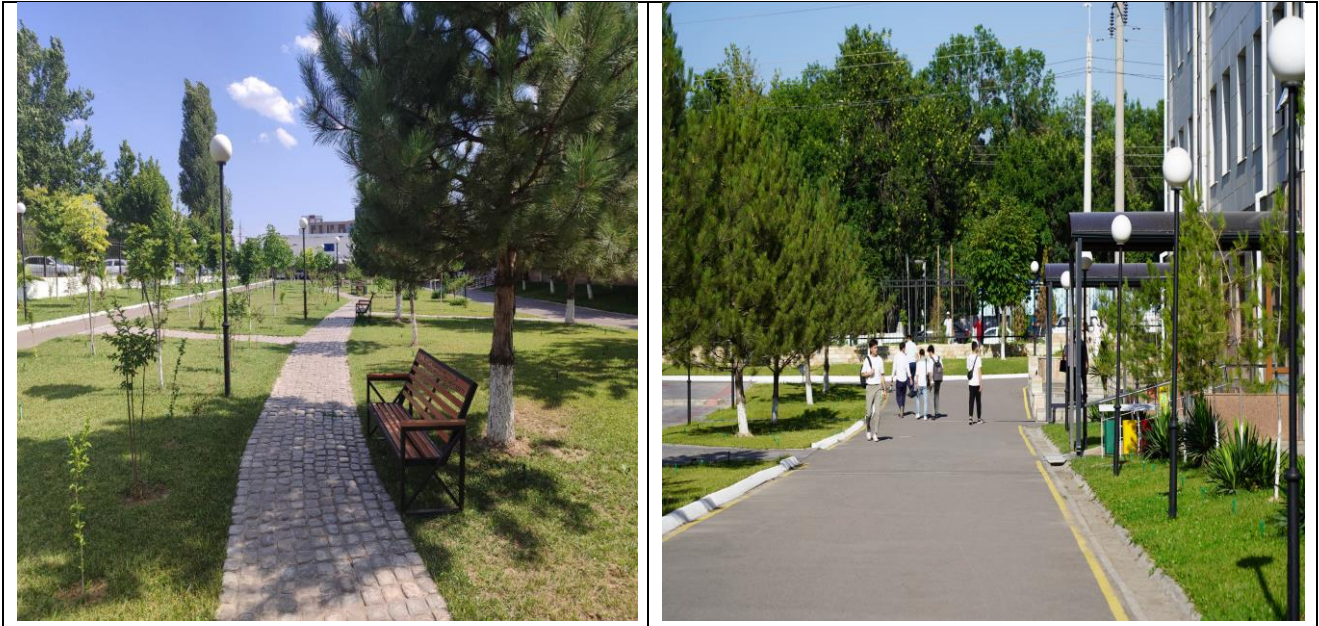
Violations of this policy may result in disciplinary action, up to and including suspension or expulsion from the university.

## [5.16] Pedestrian Path Policy on Campus



### **Description:**

The University has developed and implemented a policy aimed at ensuring pedestrian safety on campus. This policy includes a number of measures aimed at preventing accidents and creating a comfortable environment for all road users.

The main aspects of the policy:

- All footpaths on the university grounds must be marked and maintained in good condition. This includes regular cleaning, repairs and updating of markings.
- Pedestrians are required to comply with traffic rules and use only the paths intended for them.
- Appropriate signs and markings should be installed at the intersection of pedestrian paths with highways.
- Bicycles, scooters and other means of transportation, except wheelchairs, are prohibited on the territory of the university.
- Movement on lawns and other green areas is prohibited.
- To ensure the safety of pedestrians at night, all footpaths must be illuminated.

Responsible persons have been appointed to monitor compliance with the policy, who regularly check the condition of footpaths and compliance with the rules. If violations are detected, measures are taken to eliminate them and prevent recurrence.



Policy implementation results:

1. Reducing the number of accidents on footpaths.
2. Improving the level of safety and comfort for all traffic participants on the university grounds.
3. Creating a positive image of the university as a responsible and caring institution.
4. Formation of a culture of safe behavior among students, staff and visitors of the university.

The policy continues to evolve and improve based on the analysis of incident data and feedback from road users.
