



# Uzbekistan State University of World Languages (UzSWLU) Policy on Sustainable Development Goal 7 (SDG 7): Ensuring Access to Affordable, Reliable, Sustainable, and Modern Energy

## Introduction

Uzbekistan State University of World Languages (UzSWLU) is committed to supporting Sustainable Development Goal 7 (SDG 7) of the United Nations 2030 Agenda. This policy aims to contribute to achieving affordable, reliable, sustainable, and modern energy for all, both within the university community and in the broader context of Uzbekistan's sustainable development efforts.

## **Policy Objectives**

The main objectives of the UzSWLU SDG 7 Policy are:

- 5. **Community Engagement**: To collaborate with local communities and stakeholders in promoting access to modern energy services. The university will work with local governments, NGOs, and energy providers to promote sustainable energy practices and extend support to communities lacking access to modern energy solutions.

#### **Implementation Strategies**

- **Energy Audits**: Regular energy audits will be conducted to identify areas where energy consumption can be reduced and efficiency improved.
- **Green Campus Initiative**: The university will implement a "Green Campus Initiative" that includes installing solar panels, promoting the use of electric vehicles, and encouraging the use of energy-saving appliances.

• **Capacity Building**: Training sessions will be provided to faculty, staff, and students to enhance their understanding of energy conservation techniques and renewable energy technologies.

### Monitoring and Evaluation

The implementation of this policy will be monitored through an annual review of energy usage data and the progress of renewable energy projects.
