

UzSWLU Plastic Waste Reduction Policy

Approved: January 2021

Reviewed: March 2023

Introduction: The Uzbekistan State World Languages University (UzSWLU) is committed to reducing plastic waste on campus as part of its efforts to promote environmental sustainability. This policy outlines UzSWLU's approach to minimizing plastic use, increasing recycling, and fostering a culture of environmental responsibility among students, staff, and faculty.

Objectives: The main objectives of the UzSWLU Plastic Waste Reduction Policy are:

1. **Minimize Plastic Waste:** Reduce the use of single-use plastics across campus.
2. **Promote Reusable Alternatives:** Encourage the use of reusable items to decrease dependency on disposable plastics.
3. **Raise Environmental Awareness:** Educate the campus community on the importance of plastic waste reduction for environmental health.

Scope: This policy applies to all students, faculty, staff, vendors, and contractors on UzSWLU's campus.

Policy Statements:

1. **Reduction of Single-Use Plastics**
 - Single-use plastics, including plastic bottles, cups, straws, and cutlery, are prohibited in university cafeterias, offices, and at all university-organized events.
 - All vendors on campus are required to adhere to the university's plastic-free initiative and offer environmentally friendly alternatives.
2. **Promotion of Reusable Alternatives**
 - UzSWLU encourages the use of reusable water bottles, coffee cups, bags, and food containers on campus.
 - Reusable items are available for purchase at university stores, and discounts are offered at campus cafeterias for using personal containers.
3. **Recycling Initiatives**
 - Recycling bins are strategically placed throughout the campus to collect plastic waste, ensuring proper disposal and recycling.
 - The university partners with local recycling facilities to process collected plastic waste and ensure it does not end up in landfills.
4. **Educational Campaigns**
 - Regular workshops and seminars are organized to educate students and staff on the environmental impact of plastic waste.

- Awareness campaigns, posters, and online resources provide information on the benefits of reducing plastic use and adopting sustainable practices.

5. Green Procurement Policy

- UzSWLU prioritizes environmentally friendly procurement, ensuring that suppliers offer plastic-free and sustainable products.
- All departments are encouraged to consider eco-friendly materials in purchasing decisions to support the university's sustainability goals.

6. Monitoring and Compliance

- The Environmental Committee regularly monitors compliance with the Plastic Waste Reduction Policy.
- Non-compliance may result in penalties for vendors, contractors, or individuals who fail to adhere to the policy guidelines.

Monitoring and Reporting: The Environmental Committee at UzSWLU is responsible for overseeing the implementation of this policy. An annual report is published detailing the progress, challenges, and successes of the university's plastic waste reduction efforts.

Policy Review: This policy will be reviewed every two years to ensure it aligns with current environmental standards and best practices.
