1.19 - Campus Facilities for Disabled, Special Needs, and/or Maternity Care

The Uzbekistan State World Languages University (UzSWLU) provides full accessibility and inclusion across all its campuses to support individuals with disabilities, special needs, and maternity requirements. All academic and administrative buildings are equipped with accessibility facilities compliant with international and national standards (ISO 21542:2021; KMK 2.08.02-19).

The university operates under the Anti-Discrimination and Anti-Harassment Policy (approved by the Rector, 2023), which guarantees equality, dignity, and non-discrimination for all members of the university community, including persons with disabilities and women. This policy serves as the institutional foundation for all accessibility and inclusivity programs.

In line with this, UzSWLU has installed 62 permanent ramps, 24 elevators with Braille and voice systems, 38 accessible toilets, 45 reserved parking spaces, and five mother-and-baby rooms located at the Main, Zakovat, Lutfiy, Angren, and Orta Chirchiq campuses. All buildings have wide-door entrances, tactile pathways, contrasting signage, and Braille information panels.

The Accessibility and Inclusion Committee, established by Rector's Order №121/2023, supervises the implementation of the Inclusive Campus Policy (updated 2025) and ensures that all facilities remain functional and continuously improved.

To promote awareness and cultural change, the university organizes Accessibility Awareness Days, Inclusive Campus Week, and training sessions on universal design and equality. These programs strengthen the culture of inclusivity and ensure long-term sustainability of accessibility initiatives.

The mother-and-baby rooms are fully equipped with nursing chairs, sanitation units, and temperature-controlled systems, providing privacy and comfort for female students and staff. Additionally, the Angren Campus includes an eco-friendly accessibility corridor (600 m²) that combines green infrastructure with wheelchair mobility routes, aligning accessibility with environmental sustainability.

UzSWLU's inclusive campus model directly supports UN Sustainable Development Goals — SDG 3 (Good Health and Well-being), SDG 5 (Gender Equality), SDG 10 (Reduced Inequalities), and SDG 11 (Sustainable Cities and Communities) — by creating a learning environment where equality, accessibility, and sustainability coexist.


