



MEMORANDUM OF UNDERSTANDING

Between

Uzbekistan State World Languages University

and

City Clinical Hospital No. 16



On Cooperation in Healthcare Services, Medical Support, Health Promotion and Student Well-being

1. Parties

This Memorandum of Understanding ("MoU") is concluded between:

hereinafter referred to as the "**University**",

and

City Clinical Hospital No. 16

Address:

Tashkent, Republic of Uzbekistan

represented by the Director,

hereinafter referred to as the "**Hospital**".

The University and the Hospital are hereinafter collectively referred to as the "**Parties**."

2. Purpose

The purpose of this Memorandum is to establish cooperation between the Parties in providing comprehensive healthcare services, preventive medicine, emergency medical assistance, public health promotion, and psychological well-being for

students, academic staff, administrative staff, and visitors of Uzbekistan State World Languages University.

3. Areas of Cooperation

The Parties agree to cooperate in the following areas:

- Emergency medical assistance;
- Primary healthcare services;
- Hospital-level medical treatment;
- Specialist consultations;
- Preventive medical examinations;
- Vaccination programmes;
- Medical diagnostics;
- Laboratory services;
- Psychological support and counselling;
- Public health awareness campaigns;
- Healthy lifestyle promotion;
- Blood donation campaigns;
- Health education programmes;
- Medical referrals;
- Occupational health services;
- Emergency preparedness and disaster response.

4. Responsibilities of the University

The University shall:

- Provide first-aid facilities and medical rooms across university campuses;
- Operate university medical centres;
- Refer students and employees requiring specialized treatment to City Clinical Hospital No. 16;
- Organize annual medical examinations;
- Promote healthy lifestyles through educational programmes;
- Support joint public health campaigns.

5. Responsibilities of the Hospital

City Clinical Hospital No. 16 shall:

- Provide hospital-level medical services to referred students and university employees;
- Deliver emergency medical assistance when required;
- Conduct specialist consultations and diagnostic examinations;
- Support vaccination and preventive healthcare programmes;
- Participate in university health promotion activities;

- Cooperate in organizing medical seminars, workshops, and awareness campaigns.

6. Joint Activities

The Parties shall jointly organize:

- Health Week;
- Blood Donation Campaigns;
- Preventive Medical Screening Days;
- Vaccination Programmes;
- First Aid Training;
- Mental Health Awareness Events;
- Healthy Lifestyle Seminars;
- Emergency Preparedness Exercises;
- Community Health Promotion Activities.

7. Benefits for Students and Employees

Students and employees of Uzbekistan State World Languages University shall have access to:

- Emergency medical services;
- Outpatient consultations;
- Specialist medical examinations;
- Hospital treatment where necessary;
- Preventive health programmes;
- Mental health support;
- Health education activities.

8. Sustainability and Public Health

The Parties recognize that healthcare contributes directly to sustainable development.

This cooperation supports:

9. Duration

This Memorandum shall enter into force on the date of signature and shall remain valid for **five (5) years**.

It may be extended by mutual written agreement.

10. Amendment

Any amendment to this Memorandum shall be made in writing and signed by both Parties.

11. Termination

Either Party may terminate this Memorandum by providing thirty (30) days written notice to the other Party.

12. Final Provisions

This Memorandum expresses the intentions of the Parties to cooperate in the fields described above and serves as a framework for future collaborative activities.
